### INTRODUCTION TO THE REPORT

The trustees of Friends of the Wumenu Community Farm (FWCF) ('the charity') present the annual report for the period ending 31 March 2023. Friends of the Wumenu Community Farm is a registered Scottish Charity that operates in Glasgow Scotland. It is fully constituted charity. Its purpose, rules, and policies are clearly set out in the charity's constitution.

This annual report and the receipts and payment accounts are being prepared to the legal standards for OSCR charity accounts. The FRIENDS OF WUMENU COMMUNITY FARM charity does not meet the criteria for a large charity as stipulates in OSCR. It has a gross income for 2022/23 fiscal year of £9,911.

As a simple receipts and payments account are required for non-company charities with gross income of less than £250,000, this report presents a simple Receipts and Payments Accounts.

In this financial year 2022/23, the Friends of the Wumenu Community Farm has embarked on single major project call The Space Great Art Digitally. The main objective of the project is to establish a digital African Art online. The project will create social media platforms on YouTube, Twitter, Facebook and Instagram.

The project is an ongoing one. It is based on ring-fence financing agreement. In this agreement charity will pre-finance expenses and upon certificatory completion, the donors The Space Project will re-fund us.

The parties agreed on three instalment payments of £3304 per payment. So far, the charity has received two payments of £6608 towards the project. The final payment will be effected upon completion of the project.

## REFERENCE AND ADMINISTRATION DETAILS

The Friends of Wumenu Community Farm is a registered charity in Scotland, United Kingdom. It is a constituted charity that works under the guidelines of the Scottish Charity Regulator (OSCR). The charity's aims and objections can be found in its constitution.

The charity has a governing constitution. It has its trustees who oversee the affairs, and strategic plans for the charity.

The constitution spells out how its office bearers are to be selected at its annual general meetings. The procedures for meetings and the quorums needed for meetings are parts of its governing and administrative procedures.

For the Financial year 2022/23 none of its trustees left the charity, they all continue to provide a valuable service on voluntary bases.

The Charity has not conducted any activities in the year 2022/23. The charity was able to secure a grant of £9,911 to fund it's the space great art digitally. It has not received any grant, donation, or raise funds in the prior year 2022.

This was an event that was organised to enlighten our children and, remind all and sundry of Black history. It highlighted how far we came as a community. It helps highlight the challenges we still face and how as a community we can overcome those challenges.
